MEMORANDUM OF UNDERSTANDING (MoU)
Between
St. Xavier's College, Maharo, Dumka, Jharkhand, India
and
Adikala Hastshilp Producer Company Limited

This Memorandum of Understanding (MoU) is made on **15th October, 2025**, between **St. Xavier's College, Maharo, Dumka**, represented by its Principal, **Rev. Fr. Dr. Varghese Palli, S.J.** (hereinafter referred to as "**SXC Maharo**"), as the First Party, and **Adikala Hastshilp Producer Company Limited**, Dumka represented by its Director, **Baby Devi**, as the Second Party.

PURPOSE

Whereas,

a) *St. Xavier's College, Maharo, Dumka* is an undergraduate college offering programs in Arts, Science, Commerce and professional courses like BBA and BCA. It is affiliated with Sido Kanhu Murmu University, Dumka, Jharkhand, and was established in 2011 by the Jesuit Fathers of Dumka. It is a self-financed institution situated in a rural area, aiming to promote higher education among rural and indigenous communities. The college was accredited with a '**B+**' Grade by NAAC in its first cycle in 2023.

b) *SXC Maharo* is desirous of associating with *Adikala Hastshilp Producer Company Limited* in various academic areas as outlined in this MoU, which will be mutually beneficial.

Whereas,

a) *Adikala Hastshilp Producer Company Limited* is the only registered producer company dedicated to the promotion and conservation of handicrafts from the Santal region of Jharkhand. The Santal region carries a rich cultural legacy, expressed through its diverse handicraft and traditional art forms. Its cultural heritage includes Jadopatia painting, tribal musical instruments and traditional attire. The company is also known for bamboo crafts, chadar- Badoni puppetry, terracotta art as well as the intricate works.


b) *Adikala Hastshilp Producer Company Limited* is also desirous of associating with *SXC Maharo* for mutual academic benefit.

Both parties, relying on principles of good faith and their shared educational goals, agree to strengthen their relationship through academic cooperation as outlined in this MoU.

1. OBJECTIVE

The objective of this MoU is to establish a cooperative program to promote the academic, professional, and cultural development of students, faculty, and researchers at both institutions.

2. METHOD OF ACHIEVING OBJECTIVES

Both parties, through mutual agreement, shall develop specific cooperation programs and projects that will define their respective responsibilities and actions.

3. AREAS OF COOPERATION

i. **Research Collaborations:** Joint efforts in developing research proposals, conducting research, co-authoring publications, and establishing research centres.

ii. **Resource Person Exchange:** Resource person may travel between institutions to lecture, teach, pursue sabbaticals, enhance governance skills, and develop collaborative research.

iii. **Student participation:** Students may participate in academic activities/events hosted by the partner institution to enhance experience.

iv. **Integrated Studies Promotion:** Incorporating an international/intercultural dimension in teaching, research, and university services for global exposure.

v. **Information Exchange:** Sharing teaching and research-related materials, best practices, e-content, and providing library/repository access wherever feasible.

vi. **Study Tours:** Jointly organized and mutually agreed upon in writing.

4. FUNDING

- Each participant will bear their own travel, accommodation, and personal expenses.
 - Home institutions will charge regular academic fees; host institutions will support lodging and logistics.
 - Professors and researchers' costs for visits will be covered by the requesting institution.
 - All participants must obtain medical insurance.

5. NO EMPLOYMENT RELATIONSHIP


This MoU does not establish any employment or labour relationship. Each party remains responsible for their own personnel.

6. CREDITS / ACCREDITATION

- Credits will be awarded as per the host institution's academic policies.
- Host institutions will issue certificates for grades and completed work.
- Home institutions retain discretion on acceptance of credits.

7. RIGHTS AND DUTIES

- Host institutions will provide academic and administrative support.
- All participants must comply with the host institution's rules.
- Misconduct or violation of laws may result in termination from the program.
- Host institutions will assist with logistics and provide academic facilities where possible.

8. AUTONOMY

This MoU reflects intentions only and does not entail financial commitments between the institutions.

9. TERM

This MoU is valid for five (5) years from the date of execution and will be automatically renewed for another five (5) years unless terminated in writing with six (6) months' notice.

10. CONFLICT RESOLUTION

Any dispute shall be resolved through direct negotiation between delegated representatives of each institution.

11. ACTION PLANS

Each joint activity shall have a defined action plan outlining:

- Objectives and scope
- Academic and administrative details
- Intellectual property
- Financial responsibilities
- Duration
- Insurance information
